Instructions for authors

The author is responsible for the originality and quality of the contribution. Author is responsible for the English version of the contribution. Contributions are published in English and manuscripts have to contain English abstracts (including keywords).

Formatting / Style: The contribution's style should be followed. It is necessary to follow the manuscript structure showed in the template file. The extent of the contribution shall not be longer than 6 pages including tables and figures. Should the character of the contribution allow, the results shall be duly statistically evaluated. Word text editor should be used for creating the text (font Times New Roman).

Layout of the contribution: Title of the contribution (brief, exact, factual; it must express the main topic as accurately as possible; it may not contain abbreviations or acronyms with the exception of the most common ones, i.e. DNA).

Name of the author (authors) without academic degrees. Author(s) affiliation (Institute /Department, University, Address, Country). E-mail the corresponding author.

Abstract (Three hundred words are the maximum permissible in the abstract. Abstract should give a pertinent overview of the work, its purpose, the main methods or treatments applied; summarize the article's findings or facts and indicate the authors' conclusions or interpretation. Abstract must not contain results or data which are not presented and substantiated in the main body of the text.)

Key words (Five keywords without overlapping with the manuscript title and abstract is recommended.)

Introduction (Wider connections, giving reasons for the investigations and publication of the contribution, objectives of the paper.)

Material and methods (Brief description of the experimental material and methods, so that anybody can repeat the work; if the methods are not original, provide a reference where the method was originally published.)

Results (Evaluation and exact description of the achieved results and/or stating the statistical significance.)

Discussion (Confrontation of the achieved results with papers published earlier, opinion of the author on the discovered differences, his opinion on the result, outline of the need for future solution or importance for the development of science, society or practice.)

The results and discussion may be joined together.

Conclusions Acknowledgements (Acknowledgement is necessary if the paper was funded by a grant agency or other foreign sources.)

A list of refereed literature arranged in an alphabetical order according to the surname of the first authors. The full title of all authors should be followed by the original title of the paper, the year of publication cited, the name of the periodical using abbreviations, and the relevant volume and page numbers. In the case of a book, the title should be followed by the place of publication and the name of the publisher. Proceedings and thesis in references should be omitted. If the cited source is not in English, it should be translated, and the language in which

the material was published originally should be given at the end of the citation (in brackets). Only papers cited in the text should be included in the list of references.

Authors are encouraged to prepare figures and schemes in colour. Figures and schemes (both are referred to in the text as Figures) should be inserted into the main text and must be numbered (Figure 1., Figure 2., etc.) and an explanatory title must be added. Also tables should be inserted into the main text and numbers (Table 1., Table 2., etc.) and titles for all tables supplied. Authors should use the Table option of MS Word to create tables. The legends should be prepared as a separate paragraph of the text and placed in the text under a table or a figure. Concerning the content and formal side, the contribution shall respect the principles usual for scientific papers in the respective scientific branch.

Compliance with these instructions is obligatory for all authors. If a manuscript does not comply exactly with the above requirements, the editorial board will not accept it and will return it to the authors without reviewing.
